Account balance tiers and corresponding APYs for BMO Harris Select Checking are as follows: 1) 0.01% for balances up to \$9,999.99; 0.05% for balances of \$10,000 or more for our Illinois and Northwest Indiana locations, excluding locations in South Beloit, Roscoe and St. Clair County in Illinois. 2) 0.05% for all balances for all other BMO Harris locations. Account balance tier and corresponding APY for BMO Harris Portfolio Checking is 0.05% for all balances. Interest is calculated on the entire collected balance each day at the rate in effect for that balance tier. You must maintain the required minimum collected balance for each tier in order to earn the APYs disclosed. We use the daily balance method to calculate interest, by which a daily periodic rate is applied to the collected balance in the account each day. Interest is compounded daily on the collected balance and credited to the account monthly on the statement period date.
