Qualified transactions must be debit card purchases over \$50.00 in order to get cash back. ATM transactions do not qualify. Qualifying cash back transactions earn you \$0.25 per transaction. Cash back amount of \$0.25 is subject to change at any time. ATM transactions do not qualify for cash back purchases, but they do qualify for the fee rebate. Transactions must post to the account during the monthly statement cycle. This account requires you to sign up for free e-Banking, e-Statements and e-Alerts and have either free full direct deposit or at least two (2) ACH credits or debits post to your More-Than-Free Checking account during the monthly statement cycle. May be subject to 1099 reporting. Rewards and rebates will be paid on a per account basis.

\*\*While supplies last. A Checking Account with full direct deposit, e-Statements and debit card must be opened by August 31, 2017 to qualify for tablet. New Checking accounts only. Tablet must be picked up in branch only. Tablets will not be shipped to member. Tablet will be awarded after the direct deposit begins. Direct Deposit must begin within 30 days of account opening to qualify. No exceptions can be made to this qualification. Once it is determined that the member qualifies for the reward by meeting the criteria set forth, the member will be given the appropriate incentive. A \$25.00 fee may apply if account is closed within 90 days. All new accounts are subject to our normal approval process.
