GENCO membership is required to establish a Kasasa checking account. To qualify for membership you must live, work or worship in McLennan or Angelina counties.

All current GENCO members may be eligible to receive the referral incentive if all promotional requirements are met. Any existing member, who is not currently a primary member on a GENCO checking account or any new member that opens a new savings and checking may be eligible to receive the new checking incentive. Referred members must open a share savings account with a required \$5 minimum balance that must be maintained at all times. The referred member must then open a Kasasa Checking Account and meet all qualifications. If the account is referred, both the referring and referred member accounts must remain in good standing prior to bonus payout. A \$25 bonus will be awarded to the referring member and a \$25 bonus will be awarded to the referred member. Bonuses will be credited to each account once the referred account has been open for 90 days, is in good standing, and all promotion requirements are met. Cash reward offer valid July 2, 2018 through August 31, 2018. Only one bonus will be paid to the referred member. Limit ten (10) bonus referral payouts per referring member for a maximum amount of \$250. Age and other restrictions may apply. If the new account is a walk-in, the same bonus (\$25) will apply to the new member account. All GENCO new account policies and procedures will apply. New checking member must not have caused GENCO a loss in order to be eligible to open a new checking account.
