## MEMBER REFERRAL PROGRAM OFFICIAL RULES



Entry to the Member Referral Sweepstakes or participation in Member Referral Program constitutes your understanding and acceptance of these Official Rules.

## **BONUS PAYMENT**

- 1) Eligibility
  - a) **Referring and Referred Member** must, at the time of the referral:
    - i) Be a member (person or business) in good standing with the credit union at the time of referral (account cannot be overdrawn, etc.)
    - ii) Be at least 18 years old at the time of referral
    - iii) Not be an Seattle Credit Union employee, Board Director or their family
  - b) Referred Member must:
    - i) Apply for and be accepted for Seattle Credit Union membership
    - ii) Open a new Seattle Credit Union checking account of any type with a minimum \$50 deposit (cash, check or transfer) at time of opening.
    - iii) Be a new member and cannot have been an Seattle Credit Union member in the last twelve months
    - iv) Be a full member and main signer on accounts, not a "joint member"
    - v) Retain the new membership and checking account open and active for at least 90 days
- 2) Commitment
  - a) For each qualifying Member Referral, the Referring Member will receive a \$25 "Thank You Bonus" and the new Referred Member will receive a \$25 "Welcome Bonus."
  - b) Thank You Bonus will be posted to the Referring Member's **membership savings account** within three business days of the completion of the new accounts opening process.
    - i) Thank You bonuses to referring members during a calendar year totaling \$600 or more will be reported on Form 1099-MISC.
  - c) Welcome Bonus will be posted to the new Referred Member's membership savings account within three business days of the completion of the new accounts opening process and initial opening deposit of \$50 made into a new checking account.
    - i) Welcome bonus is considered interest and may be reported on IRS Form 1099-INT.
  - d) If the new account is closed early the "Welcome" bonus may be reversed.
- 3) Exclusions and Restrictions
  - a) The Member Referral Program will be monitored for compliance. If program conditions are not met, by Referring Member and/or qualifying Referred Member, any payout of cash bonuses will be reversed.
  - b) All new accounts are subject to Seattle Credit Union standard <u>Membership Agreement</u> terms and conditions
  - c) Joint Members: If a joint member refers a qualifying New Member, the Thank You Bonus will be deposited into the Membership Savings Account of the associated full membership.
  - d) Seattle Credit Union reserves the right to cancel or amend the terms of the Member Referral Program at any time and without notice.
