#### How it works:

To make a referral, make sure that your friend or family member lives in Southern California. They will need to mention this promotion and your name at the account opening. You can refer as many people as you like. To qualify for the referral program, at least one person from the referring relationship must be 18 years of age. Credit Union eligibility requirements apply.

**Terms and Conditions: Refer a New Member** and referring Member information must be provided during the application process, retroactive referrals will not be eligible. Maximum incentive is \$150 per New Member/Referring Member relationship. The incentive is only for new member accounts, not new accounts for existing members or joint owners and is based on account openings, not applications. POLAM member who closed an account within 180 days of the promotion start date will not be eligible for a promotional reward. A Joint Account Owner age 18 or older is required for Members under 18. For a checking account and debit card account holders must be at minimum 16 year or older with a joint owner who's 18 or older. If criteria is met and the referring member is in good standing, Referring and New Member's Primary Savings Accounts will each receive the \$50, \$100 or \$150 incentive by the 25th of the following month after the new Primary Savings Account is opened. Minimum balance to open a new account is \$100. The new account must remain open and in good standing when the reward is processed. The full amount of reward must remain on the account for 1 year. The incentive will be a taxable dividend on the appropriate 1099 IRS Form we will send to you in January the following year. Payment of taxes on incentive will be the responsibility of the recipient. Maximum incentive is \$250 per Member/Referring Member relationship. There is only one loan incentive per Member/referring Member relationship. The incentive is only for new member accounts, not new accounts for existing members or joint owners and is based on account openings, not applications. To receive the incentive the loan must be for a minimum of \$5,000 for a personal/auto loan or \$50,000 for a mortgage. Incentive will be deposited 30 days after loan closes. The account must remain in good standing. The incentive will be a taxable dividend on the appropriate 1099 IRS Form we will send to you in January the following year. Payment of taxes on incentive will be the responsibility of the recipient. This is a limited time offer. Offer is subject to change and may be discontinued without notice.
